GJFC Origins & History

In 2024, We celebrated the 60th Anniversary of Greensborough Junior Football Club. The club was founded back in 1964, and our origins are closely linked to the rise of junior football in the Diamond Valley area.

In 1966, Greensborough Football Club President and All-Australian footballer Joe Murphy, brought junior football to the Diamond Valley area. Two Greensborough under 15 teams, the Colts and the Rovers, played in the now disbanded Preston/Reservoir Junior Sunday Football League. Four Greensborough under 13 sides, known as the Blues, the Blacks, the Golds and the Maroons, two Watsonia teams and one Montmorency team formed the Greensborough Midget League.

In 1968, the administration of Junior Football was handed over to the DVFL, and the competition as we know it today commenced, with senior teams fielding Under 13 and Under 15 sides.

By 2001, Greensborough Junior Football Club had 11 teams from Under 10's through to Under 17's. At that point, the club relocated to Anthony Beale Reserve, it's current home. At the time, with 2 grounds and a state-of-the-art pavilion, it was the premier facility for the Diamond Valley League.

Girls' football was introduced to Greensborough Junior Football Club in 2015. In the first year, there were 3 teams; Under 12, Under 15 and Under 18. The girls got off to a successful start with the Under 15's winning the Premiership.

2024 Major Achievements:



ANZAC day memorial

GJFC had an incredible representation at the march and, while we have no records, it must surely have been right up there with the best of them.

Sir Doug Nichols Round

With our new indigenous jumpers, we were able to show strong support for the Sir Doug Nichols round, in which we were able to share his incredible story with our players. We also supported Naidoc week.

Acting on community feedback



We were quick to respond to community feedback on the long lines for the canteen in the early weeks of the season. Our response was to cook eggs and bacon on the BBQ in the mornings, which was incredibly successful. Not only did we solve the problem, but it was also so popular that it is surely here to stay.



Visit from Carlton Football Club

One Thursday night during the season we had a visit from three Carlton footy club players. Feeback from the CFC was extremely positive and the players thoroughly enjoyed themselves.

Striking the right balance

This year, we launched our new team selection policy and ended the year with 6 (of 9 possible participants) teams making finals footy. Two of these teams were our White teams, which highlights that we aren't just here to win, we want to have kids playing in teams where they have a chance to contribute to success.

A Club-wide effort.

Our U15s were one of the biggest stories for this year. As late as March, we were still concerned that we may need to fold the side due to numbers. Through a combined effort of calling other clubs, supporting the coaches and the players themselves recruiting, they pulled together a team – a team that went on to win the flag. It is simply one of the best stories of the year.



Suggestions raised by last year's executive:

In the 2023 Annual Report, Andrew (Teddy) Cleary observed that a number of issues needed to be addressed by the incoming executive. We tackled each of them in turn.

1. The club should move from the outdated Outlook email to something more secure such as Gmail. We have been hacked twice in two years with the scammers becoming better at what they are doing.

We tackled the security of our email very early on. Our investigation showed that every email sent by the executive was being forwarded to a Gmail account. We quickly disabled this forward and reset all the club's email addresses. For added security, we have implemented a two-factor process when dealing with requests for money to protect us from any financial loss in the event that our email is hacked in the future.

2. Committee members embrace the implementation of TidyHQ, which will streamline the running of the Club.

TidyHQ has brought some benefits to the club over the last 12 months. It has proved extremely effective for running meetings and tracking actions, and also enabled us to introduce paid and unpaid ticketing for the events we ran during the year. However, it does have significant limitations. There's no capacity to share and edit documents, the merchandise is actually much easier to manage in Square, and we've yet to establish an effective match with the registration data in PlayHQ. If we are re-elected into our executive roles for the 2025 season, we will be looking for an alternative membership management solution.

- 3. Committee members need to be rostered to assist with match day set up, pack up and the match day manager role. It can't be expected to be left to the executive each week.
 We achieved some success with sharing the load across the entire committee this year, but ultimately we believe we need to cast the net to the wider club community—and beyond—to take on these kind of roles during the season. The work to find these volunteers should be one of the first jobs for the 2025 committee.
- 4. Somebody volunteers to make the establishment of a girls team their project. It needs plenty of time devoted to it.

From our experience this year, the same could be said about every aspect of running the club, and we have tried to instil accountability for actions over the course of the year. With little handover and plenty to get to grips with in 2024, we set ourselves the goal of forming a girls' team by 2025. Since then, we have worked with the Auskick team throughout the year to make that happen. As things stand at the moment, we are extremely confident that we will form one—if not two—girls' teams in 2025.

5. More emphasis is placed on the mental health and wellbeing of our members. Our Club Chaplain Greg Shambrook is always more than happy to speak to anyone who may be struggling. Our players could utilise the services of our not for profit partner headspace Greensborough.

Looking after the mental health of our players is extremely important and we value our partnership with Headspace. This year, we organised a mental health night and have identified that the club needs a Child Safety Officer in place by the start of the 2025 season.

Grand plans

When we moved into our executive roles towards the end of 2023, we discussed and agreed a number of objectives that we felt were essential for the club to tackle in the short- to medium-term. They were:

Embed technology across all club processes

We're giving this one a big tick. This year, we have installed Wi-Fi, run all our registrations through PlayHQ and used a specialist club management software to help us run committee meetings, record actions and market events. Next year, we hope to establish better communication channels across the club and are looking at the right options to do that. We also implemented a new medic app: *Sports Buddy Hurt*, which eliminates the need for paper injury forms as well as helps the club keep track of injuries and medics' qualifications. We really have brought injury management into the 21st Century.

Ensure every player is playing at the right level to help their development and nurture their love for the game

This year, we rolled out the club's team selection policy. From our perspective, it was a winner. We have not only fielded competitive teams playing at very high levels, but we've also seen plenty of kids given time and space to improve their skills at a lower level – and many have reaped the benefit. Perhaps more importantly, we've seen plenty of evidence that players at all levels have really enjoyed their footy this year.

Develop a plan to improve the club's on the couch sessions

We've certainly tried to make this work. One of the biggest problems with On The Couch is the amount of effort it takes to run – it usually means a 12-hour football Sunday for some, if not all of those involved. This year, we've made a conscious effort to run less sessions – with varying degrees of success. In terms of money, despite fewer nights, we've made more than last year. We've also replaced some of those On the Couch sessions with a quiz night and a cocktail party, to mix things up a little. But we're also mindful that it hasn't been perfect. If the executive is re-elected, we will work to get this right in 2025.

Develop a club membership structure that benefits all and truly represents our tagline of #AllMyLife

There have been too many new systems to deal with to get this up and running this year. While our internal system, TidyHQ should help us to do this, it doesn't play particularly nicely with PlayHQ. So while this is very definitely something on the radar for next year, the optimum way to deliver it still needs some thought.

Celebrate the club's 60th Anniversary in 2024

We're really proud to have led the club through its 60th anniversary this year and would like to thank all those involved in bringing the events and plans to life.

Improve the reciprocal relationship with GFC and ensure it operates for mutual benefit

There's plenty more work to do on this, but we worked very closely with the senior club this year while working through registrations and transfers, and have engaged regularly throughout the season. There's more we can do, but we believe we have certainly established a solid foundation to build on next year.

Get the ball rolling on girls' footy at GJFC

This has been a huge priority for us this year, and while we can't be certain until the teams for 2025 are locked and loaded, we believe we will field one, if not two girls' teams next year.

Finally, we set one objective that we've not gained much traction on:


Develop and implement a strategy to retain our existing players and attract new ones. We're still working on a plan for this – it's a huge objective and one that we need to get right.

On top of all that, we installed a new scoreboard, something that has been a constant agenda item for the club's various committees for more than five years. What we now have is more than a scoreboard, it's a working asset that we can use for promotion and community purposes, as well as generating additional revenue for the club. This was made possible by a sizeable donation from Greensborough RSL and a great deal of work from Simon Harding and Kaine Plummer.




2025 and beyond

As the club's executive for next season has not yet been appointed, it is difficult to plan too far into the future. However, we have devised a one-page strategy for the club and hope future committee members will feel it is worth continuing with. The strategy is shown on the next page.



As well as the strategic plans we have for the coming year, there's the small matter of the clubhouse refurbishment. Thanks to the work and advocacy of Councillor Elizabeth Nealy, Banyule Council approved the \$1.8 million refurbishment of the pavilion at Anthony Beale Reserve. This refurbishment will deliver a fully accessible, female-friendly pavilion with modern change facilities, improved social spaces and a dedicated room for medics.





Of course, this is also an investment in the community. The improved social spaces will create opportunities for community groups – beyond sporting clubs – to benefit from a place to meet.



Football Director's Report

When our teams started training – in some cases as early as November – we were still developing our approach to selecting teams and pulling together the right comms to share with parents; after all, this was the first year we would be implementing our team selection policy. For the first time, we would be grading our players to ensure each of them could play in an environment that allowed them to develop their skills and nurture – in some cases rekindle – their love for the game.

As we moved into early 2024, the process of grading began for the age groups who were likely to field two teams: U11, U12 and U14. We were happy with the way the process ran and, while it certainly wasn't perfect, there's no question the club and coaches learned a lot from it. We are positive we will be able to improve the process next year.

Part of the change meant locking down the naming conventions for our teams. From here forward, where we field two teams in an age group, the higher-level side will be 'Green' and the second side 'White'.

The challenge of selecting teams for the season was made harder by us not having confirmed coaches for our U14 Whites and our U12 Whites at the time. Thankfully, through the existing network of coaches and parents we were able to fill all of these roles prior to the start of the season.

Player numbers were another huge challenge this year. While the total number of players registered in 2024 was very much on par with 2023, there was a different mix of players. For three age groups – U10, U11 and U12 – we had too many players for one team but not enough for two. We made the decision to try and make as many teams as possible even if some of those teams ended up being a little short (we didn't want players either missing out on games each week or not being able to play all together). There were, however, issues early on. A couple of the teams were short of numbers every week and this proved challenging.

Working with the coaches of those groups we were able to manipulate numbers and move a group of U10 players up to U11, and, in turn, some U11s played in U12. For the most part, this was successful: both U11 teams and one U12 team ended up making it through to finals.

Our older age groups also struggled for numbers early on. Our U15 were very short of players before the season started and very nearly folded. Our U16 lost a few players very late in preseason and seemed beset by injuries throughout. Despite these challenges, both teams had remarkably successful seasons and won the flag in their respective divisions.

In terms of on-field performance, 9 of our teams played in age groups that were eligible to play finals. Of those 9, 6 made it through to finals and 4 to the final week. Congratulations to the following on taking out the flag this season:

Registrations Report

With the NFNL moving to PlayHQ, 2024 was always going to be an interesting year for registrations. As a club, we had hoped the move to PlayHQ would mean we could finally be treated by the league as a separate entity to the senior football club, but it was not to be; the new system simply replicated some of the failings of the old one.

In addition, a delay in the release of PlayHQ to the clubs meant registrations couldn't open in the first week of November when they usually do. Not only did this mean we were behind the 8-ball when registrations finally opened the week before Christmas, but it also meant we had to try and encourage our families to sign up at a particularly expensive time of year. In response, we extended the early registration discount until late January.

In terms of players, by the time registrations closed, we had equivalent numbers to last year – no mean feat considering, as we've known for years, we would have no under 17s team this year.

PlayHQ itself has made registrations relatively simple to manage. We were able to take payment at the time of registration and could easily apply discount codes, which meant we weren't chasing registered players for payment. However, being considered the same entity as the senior club made it difficult to ask additional questions at registration – we were very limited by having to try and ensure we weren't asking questions to people for whom they were irrelevant.

This year, our members provided feedback on some aspects of our registrations that prompted us to take action. The first was that the NFNL does not automatically refund their levy if a player cancels their registration. As a club, we have decided that we will give this money back and then try and claim it in bulk from the league.

Secondly, it was pointed out that for families with three children, the registration fees for the year, even with the additional sibling discount, amounted to almost \$1000. As soon as this was pointed out, we made the decision to significantly reduce the price for a third – or more – child, and we hope this will be reflected in future years.

All in all, the move to PlayHQ has been a positive one for us as a club and we hope that the new functionality will continue to improve the registration process in coming years. What we are hoping to find in 2025 is a way to allow and automatically administer registration payments by instalment.

Unsurprisingly, he is well respected by his peers across the committee and the executive and has been an important component in the club's financial, on-field and off-field success.

The Joe Murphy Trophy

The name Joe Murphy is synonymous with Greensborough Junior Football Club. Joe came to Greensborough from Fitzroy in 1954 as Captain-Coach and won the first of two DVFL Best and Fairest awards in that year.

From 1955 to 1958, he was Captain-Coach of Latrobe Football Club in the NWFU in Tasmania. He represented Tasmania in the State Carnivals and won All Australian selection. Joe was Captain-Coach of the 1960 and 1961 premiership sides, and won his second DVFL Best and Fairest award in 1961. Many observers regard Joe Murphy as the best player ever to play DVFL football. Following various positions on the Greensborough committee, Joe was Club President from 1966 - 68, and was the instigator of junior football in the area.

Everybody connected with DVFL football was saddened by the passing of Joe at a comparatively young age on June 7, 1985 from a terminal illness. In 1986, as a tribute to the vision of Joe Murphy, the Greensborough Junior Football Club created a perpetual award known as the Joe Murphy Trophy. A shield is displayed in the clubrooms, and the player is presented with a trophy.

Players must be nominated for the Award and it is voted on by the Executive Committee. The criteria includes: Years at the club, Stature at the club, Involvement ON and OFF the field, and leadership qualities. The winner is always well respected by peers and committee, shows integrity, sets a good example to the younger players, exhibits and promotes club values, and is of good character.

It is usually awarded to an U17 player. With none at the club this year, the Executive took the decision not to award the trophy this year.

The Ray Dickson Coaches Award

Ray Dickson was a coach whose goal was to improve every player. It wasn't about winning but about the improvement and keeping the players playing. He wanted to improve players and help them progress to play senior football. He was about the community and players showing due respect when they were out in public.

Ray was held in high esteem by the players and the parents for his attitude towards the players.

To win the award, a member must be first be nominated. They are then voted on by the executive committee. To win the award, a coach must show that they have improved the players in their side, have coached for more than 2 years, coach players to higher levels, coach respect for the community and give every player game time – even in hard situations.

This year, the trophy has been awarded to **Brett Cook**, our football director and coach of our U16s. Below is the verbatim nomination from one of the parents in our U16 team.



It is with great pride and admiration that I nominate Brett Cook, the U16 coach, for the prestigious Ray Dickson Award. Brett's unwavering dedication to his players and the club has been nothing short of extraordinary, and his impact on the team, the parents, and the community is truly commendable. Brett has consistently demonstrated an exceptional ability to improve each player on his side. His commitment to individual development is evident in the countless hours he spends working with players throughout the week, and providing personalised feedback and guidance after every game. This tailored approach has not only enhanced their skills but also boosted their confidence and overall performance.

Under Brett's leadership, the team has achieved continuous growth and camaraderie, a testament to his highlevel coaching. His strategic acumen and meticulous planning have been instrumental in navigating the team through multiple seasons, ensuring that every player has the opportunity to play and grow regardless of their personal circumstances or ability. The relationship he has with the boys is admirable, and when he asks them to do something important, such as attending the Pat Cronin presentation, they all listen.



Congratulations to Brett Cook, for taking out the Ray Dickson Trophy and also guiding the U16s to their first flag.



Treasurer's Report

Above all else, the role of treasurer is to ensure the club is in good financial health. And while that's clearly a prudent strategy, being too cautious about how money is spent can prevent the club from moving forward.

This year the entire committee was unanimous that we would take a two-pronged approach to the club's finances. Rather than simply delivering a significant net profit like the club had in previous years, we wanted to ensure surplus funds were actually used towards further improving our members experience with the club. We are, after all, a not-for-profit organisation. Specifically, our aim was to ensure the club remained financially stable while also looking to invest the surplus funds to take the club forward.

As a result of this approach, we invested significant funds into new club assets that GJFC will benefit from for many years to come. In total, we invested almost \$57,000 on:

\$40,000	Scoreboard (Includes Installation)
\$13,375	Indigenous Jerseys for U11 upwards
\$2,500	Upgraded Deep Fryer in Canteen
\$850	New BBQs (Heavily discounted thanks Diamond Valley Mitre 10)

Another focus was to ensure we gave back to our members where possible, while still being mindful that our operating expenses would likely increase more rapidly than in previous years, given the current rate of inflation. Some of the avenues we tried to give back to members were as follows:

Additional thanks go to Lyndall, Chris and Teaghan who ran the Canteen this year and implemented some new menus and a new approach. After a few teething issues and a major equipment breakdown, the team were successful in getting the canteen running smoothly and providing lovely healthy options in addition to the existing menu.

Finally, we are very grateful to Tony Black, whose friendly approach to running the bar again this year has been such an asset to our club.

It's been a great year, and while our net profit is half what it was last year, this year the club has invested \$57,000 in assets, and given over \$40,000 worth of value back to our members. Despite this, the club remains in an extremely healthy financial position, with \$106,344 cash at hand, some of which will fund further investments in 2025.
